A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN THE JOINT SPECIAL ORDER CREATING A TECHNICAL WORKING GROUP FOR THE REHABILITATION AND DEVELOPMENT OF ZAPOTE RIVER SPEARHEADED BY THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG).

WHEREAS, on 11 June 2018, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign the Joint Special Order creating a Technical Working Group for the rehabilitation and development of Zapote River spearheaded by the Department Of Environment and Natural Resources (DENR), Department of Public Works and Highways (DPWH) and Department of the Interior and Local Government (DILG) for and on behalf of the City of Bacoor ;

WHEREAS, the TWG's main task is to formulate a long term plan for Zapote River rehabilitation and development which will focus on the following phases: (1) clean-up of waterways draining to Zapote River and its surroundings barangays, (2) establishments of engineering structure to facilitate flow of water in the river, and (3) maintenance and protection of the river.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola, duly seconded by Hon. Venus D. De Castro in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign the Joint Special Order creating a Technical Working Group for the rehabilitation and development of Zapote River spearheaded by the Department of Environment and Natural Resources (DENR), Department of Public Works and Highways (DPWH), and Department of the Interior and Local Government (DILG).
