





CITY RESOLUTION NO CR 2018-064

A RESOLUTION DIRECTING ALL OFFICERS OF HOMEOWNERS ASSOCIATIONS, AND OFFICIALS OF BARANGAYS IN THE CITY OF BACoor TO MONITOR THE ACTIVITIES OF ALL HOUSEHOLDS AND PERSONS IN VARIOUS GRASSLANDS WITHIN THE CITY TO PREVENT THE OCCURRENCE OF GRASS FIRES.

WHEREAS, last 16 May 2018, the Office of the Sangguniang Panlungsod received an endorsement letter from the Office of the City Mayor requesting for an ordinance regulating open burning under certain conditions and providing penalties for violations thereof together with a report from the City Fire Marshall, which is a comparative data of occurrence of grass fire as compared to other types of fires that they respond to.

WHEREAS, under Section 458(1)(V) of Republic Act 7160, otherwise known as the New Local Government code of 1991 *"the Sangguniang Panlungsod is empowered to protect environment and impose appropriate penalties for acts which endanger the environment xxx and such other activities which result in pollution xxx of ecological balance."*

WHEREAS, Republic Act No. 9003 prohibits the burning of any type of waste or rubbish and local government units are enjoined to implement the said law.

WHEREAS, despite the best efforts of the City Government and of the Bureau of Fire Protection, there has been an increase in the number of grass fires within the city from January to April of this year.




