







CITY RESOLUTION NO. CR 2018-065  
Series of 2018

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAYS MALIKSI I AND MALIKSI III, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF TEN MILLION PESOS (PHP 10,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR RELIEF AND REHABILITATION OPERATIONS.

**WHEREAS**, a fire broke out in Barangay Maliksi I which rapidly spread to adjacent houses in Barangays Maliksi I and Maliksi III, City of Bacoor, Cavite in the evening of 20 June 2018 resulting in massive damage to property and the displacement of around 400 families whose houses were destroyed.

**WHEREAS**, the City of Bacoor Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 06, Series of 2018 dated 21 June 2018 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangays Maliksi I and Maliksi III and authorizing the release of Ten Million Pesos (PhP 10,000,000.00) from the Disaster Risk Reduction and Management Fund.

**WHEREAS**, a copy of the said CBDRRMC Resolution No. 06-S-2018 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.

**WHEREAS**, the Sangguniang Panlungsod convened in special session in the afternoon of 21 June 2018 to deliberate on the foregoing.

**NOW THEREFORE**, upon motion of Councilor Venus D. De Castro duly seconded by Councilor Alejandro F. Gutierrez in special session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangays
