A RESOLUTION AUTHORIZING THE CITY MAYOR (1) TO SIGN AND EXECUTE THE APPLICATION FOR ACCREDITATION OF THE CITY OF BACOR AS LGU-MOBILIZER WITH THE SOCIALIZED HOUSING AND FINANCING CORPORATION (SHFC); (2) TO REPRESENT THE CITY IN ANY PROCEEDING BEFORE THE SHFC, OR SUCH OTHER BODY, IN RELATION TO THE APPROVAL OF THE SAID APPLICATION FOR ACCREDITATION (3) TO SIGN AND EXECUTE ON BEHALF OF THE CITY THE IMPLEMENTING AGREEMENT OR MEMORANDUM OF AGREEMENT TO CARRY OUT THE ACCREDITATION OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR AS COMMUNITY MORTGAGE PROGRAM AND/OR LOCALLY INITIATED COMMUNITY MORTGAGE PROGRAM (L/CMP) MOBILIZER WITHIN THE CITY AND EXPRESSING NO OBJECTION TO THE POSSIBLE ACCREDITATION OF THE CITY GOVERNMENT AS CMP AND/OR L/CMP MOBILIZER BY THE SHFC.

WHEREAS, on 26 February 2018, the Sangguniang Panlungsod of the City of Bacoor passed City Ordinance No. CO 6-2018 creating the City of Bacoor HOUSING URBAN DEVELOPMENT AND RESETTLEMENT DEPARTMENT (HUDRD) with the main purpose of consolidating all efforts and activities related to the in-city socialized housing program of the city government for the benefit of the under privileged and homeless residents of Bacoor;

WHEREAS, under CO 6-2018, two HUDRD Divisions were created particularly the Housing and Homesite Regulation Division which will be in-charge of Community Mortgage Services (among other functions) and the Community Development and Support Services Division which is in-charge of services and activities for social preparation;

WHEREAS, on May 15, 2018, the City Housing Urban Development and Resettlement Board approved the Bacoor Relocation and Resettlement Action Plan (RRAP) that would cover programs and projects for the resettlement and relocation of about 12,472 informal settler families (ISFs) living in the ten (10) coastal barangays and in the ten (10) barangays along the banks of the Zapote-Las Piñas River, or in high risk areas, and the rest of the more than thirty thousand ISFs residing in privately owned lots, along other riverbanks within the city, alongside creeks, on public roads and in other publicly owned lands;

WHEREAS, the Socialized Housing and Finance Corporation Circular No. 13-025 (also known as "the Guidelines for Accreditation of Community Mortgage Program (CMP) and/or Locally Initiated Community Mortgage Program (L/CMP) Mobilizers) define "CMP and/or L/CMP mobilizers" as an organization working with communities of informal settlers and duly accredited by SHFC which may either be an LGU, a national government agency (NGA) bureau or corporation, or NGO whose principal purpose is to assist, organize and prepare communities for participation in the CMP and/or L/CMP;

WHEREAS, for LGU's to be accredited as CMP mobilizers by the SHFC, Circular No. 13-025 provides that the LGU must submit a Sangguniang Panlungsod Resolution authorizing the LGU to participate as a partner of the SHFC in the CMP and/or in L/CMP, and another document showing that there is already Unit/Department within the local government that will handle the processing of CMP and/or L/CMP;

WHEREAS, considering that the second requirement mentioned in the immediately preceding paragraph had already been met with the creation of the HUDRD through the approval of CO 6-2018 by the Sangguniang Panlungsod, all that the city government needs now in order for it to be accredited as a CMP and/or L/CMP Mobilizer by the SHFC is a resolution authorizing the city government to participate as a partner of the SHFC in the implementation of the CMP and/or L/CMP;

NOW THEREFORE, upon motion of Councilor Edwin G. Gawaran duly seconded by Councilor Rowena Bautista-Mendiola in its 26th regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY**
