A RESOLUTION APPROVING THE FIVE (5) YEAR PLAN OF THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE ON THE UTILIZATION OF THE UNEXPENDED BALANCE OF THE 2017 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND AMOUNTING TO NINETEEN MILLION TWO HUNDRED EIGHTY THREE THOUSAND THREE HUNDRED THIRTY SEVEN PESOS AND NINETY SEVEN CENTAVOS. WHEREAS, on 15 March 2018, the Bacoor City Disaster Risk Reduction and Management Council (BDRRMC) passed Resolution No. 02, Series of 2018 entitled, "A Resolution Adopting the Five (5) Year Plan of the Bacoor Disaster Risk Reduction and Management Office on the Utilization of the Unexpended Balance of the 2017 Local Disaster Risk Reduction and Management Fund".

WHEREAS, a copy of the said resolution was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.

WHEREAS, the unexpended balance of the LDRRMF is **Nineteen Million Two Hundred Eighty Three Thousand Three Hundred Thirty Seven Pesos and Ninety Seven Centavos (PHP19,283,337.97)** that was sourced from the portion of the said fund that was not utilized during the 2017 fiscal year.

NOW THEREFORE, on motion of Councilor Alejandro F. Gutierrez duly seconded by Councilor Venus D. De Castro in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to approve the five (5) year plan of the Bacoor Disaster Risk Reduction and Management Office on the utilization of the unexpended balance of the 2017 Local Disaster Risk Reduction and Management Fund amounting to **Nineteen Million Two Hundred Eighty Three Thousand Three Hundred Thirty Seven Pesos and Ninety Seven Centavos (PHP19,283,337.97)**.
