A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN THE ENTIRE CITY OF BACOOR DUE TO WIDESPREAD FLOODING BROUGHT ABOUT BY THE ENHANCED SOUTHWEST MONSOON DUE TO TROPICAL STORM "HENRY" AND AUTHORIZING THE CITY MAYOR TO DISBURSE THE AMOUNT OF SEVEN MILLION PESOS (PHP7,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED FOR RELIEF AND REHABILITATION OPERATIONS AND OTHER INCIDENTAL EXPENSES RELATIVE THERETO.

WHEREAS, on 18 July 2018, the Bacoor City Disaster Risk Reduction and Management Council (BDRRMC) passed its Resolution No. 8, Series of 2018 entitled: "A RESOLUTION REQUESTING THE SANGGUNIANG PANLUNGSOD TO DECLARE THE EXISTENCE OF A STATE OF CALAMITY IN THE ENTIRE CITY OF BACOOR DUE TO FLASHFLOODS BROUGHT ABOUT BY THE ONSLAUGHT OF THE ENHANCED SOUTHWEST MONSOON DUE TO TROPICAL STORM "HENRY".

WHEREAS, the continuous rains brought about by the enhanced southwest monsoon due to typhoon "HENRY" inundated large parts of the City of Bacoor affecting around 36,589 families residing in 63 of the 73 barangays in the city;

WHEREAS, after deliberating on BDRRMC Resolution No. 8 and the various supporting documents presented before it by the City Social Welfare and Development Office (CSWDO), the Sangguniang Panlungsod unanimously voted in favor of declaring the entire City of Bacoor under a state of calamity.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, in special session duly assembled to declare the entire City of Bacoor under a **STATE OF CALAMITY** due to the extensive damages to property caused by the monsoon rains enhanced by typhoon "HENRY" and authorizing the City Mayor, Hon. Lani Mercado-Revilla, to disburse Seven Million Pesos (PhP7,000,000.00) from the Disaster Risk Reduction and Management Fund to be used for relief and rehabilitation operations and other incidental expenses related thereto.
