A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE NATIONAL BUREAU OF INVESTIGATION (NBI) ON THE NBI SATELLITE OFFICE IN THE BACOR GOVERNMENT CENTER (BGC) BACOR BOULEVARD, CITY OF BACOR, CAVITE.

WHEREAS, the National Bureau of Investigation (NBI) needs facilities accessible to the public pursuant to its decentralization thrust to provide convenience to the transacting public and save on rental fees and equipment expenditures.

WHEREAS, the Sangguniang Panlungsod passed City Resolution No. 2013-20 dated 28 January 2014 entitled: "A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL BUREAU OF INVESTIGATION (NBI) FOR AND ON BEHALF OF THE BACOR CITY GOVERNMENT REGARDING THE ESTABLISHMENT OF A SATELLITE NBI OFFICE WITHIN THE CITY".

WHEREAS, the NBI is presently occupying an office space within the Bacoor Government Center (BGC) located at Bacoor Boulevard, Barangay Bayanan, City of Bacoor, Cavite that serves as its Satellite Office. However, the agreement between the NBI and the city government regarding the use of the said office space is set to expire on September 2018. Thus, there is a need to renew the previous Memorandum of Agreement;

WHEREAS, the Office of the City Mayor submitted a draft copy of Memorandum of Agreement renewing the original agreement alluded to above to the Sangguniang Panlungsod for review and consideration.


NOW THEREFORE, upon motion of Councilor Venus De Castro duly seconded by Councilor Alejandro F. Gutierrez, in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve a resolution authorizing the City Mayor to sign a Memorandum of Agreement for and in behalf of the City Government of Bacoor with the National Bureau of Investigation
