A RESOLUTION SEEKING TO FURTHER IMPROVE THE DELIVERY OF PUBLIC SERVICE BY ADOPTING AND APPROVING THE CITIZENS' CHARTER OF ALL THE DEPARTMENTS AND UNITS OF THE LOCAL GOVERNMENT OF THE CITY OF BACOOR PURSUANT TO THE RELEVANT PROVISIONS OF REPUBLIC ACT NO. 9485 (ALSO KNOWN AS THE "ANTI-RED TAPE ACT") AS AMENDED BY REPUBLIC ACT NO. 11032 (ALSO KNOWN AS THE "EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018").

WHEREAS, on August 3, 2018, the Sangguniang Panlungsod received a letter from the Office of the Human Resources Development and Management Department (HRDMD) requesting the city council to pass a resolution adopting and approving the citizens' charter of all the departments and units of the city government.

WHEREAS, Republic Act No. 9485, also known as the Anti-Red Tape Act (ARTA) as amended by Republic Act No. 11032 (the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018") mandates all local government units to formulate Citizens' Charter as a tool to expedite the delivery of services to the public.

WHEREAS, the Citizens' Charter of the various departments and units of the local government of the City of Bacoor were made in response to the widespread clamor for better and more efficient delivery of public service.
