A RESOLUTION DESIGNATING ATTY. MARIA MELISSA G. TORRES AS AUTHORIZED REPRESENTATIVE TO THE DANGEROUS DRUGS BOARD ON THE CITY LEVEL.

WHEREAS, the proliferation and use of illegal drugs has caused moral degradation, disease, crimes and deaths to numerous Filipinos;

WHEREAS, RA 9165 or the **Comprehensive Dangerous Drugs Act** provides that it is a declared policy of the State to provide effective mechanisms or measures to re-integrate into society individuals who have fallen victim to drug abuse or drug dependence through sustainable programs of treatment and rehabilitation;

WHEREAS, the **Local Government Code** mandates that barangays shall adopt measures towards the prevention and eradication of drug abuse.

WHEREAS, **Agency Memorandum Circular No. 2017-018** requires a lawyer to become an authorized representative;

WHEREAS, the Department of Interior and Local Government Unit issued: **DILG MC NO. 2018-49** requiring under the Peace and Order category the declaration of being a drug free city or drug free barangay to qualify in the Seal of Good Local Governance;


WHEREAS, **DILG -DBB JMC No. 2018-01** provides for the requirements to become a drug free local government unit;





