**A RESOLUTION APPROVING THE RE-ALIGNMENT OF CONTINUING APPROPRIATION OF 20% DEVELOPMENT FUNDS FOR FISCAL YEAR 2015 INTENDED FOR THE PURCHASE OF LOT AND PURCHASE OF MEDICAL EQUIPMENT AT THE CITY OF BACOR AND ALLOCATE THE SAME TO OTHER PRIORITY PROJECTS OF THE CITY GOVERNMENT OF BACOR FOR CURRENT YEAR 2018.**

**WHEREAS**, on 03 August 2018, the Office of the City Mayor sent an endorsement letter to the Sangguniang Panlungsod requesting for the approval of the proposed realignment of continuing appropriation of the funds intended for the purchase of lot at Bacoor and for the purchase of medical equipment funded from 20% Development Fund for the Fiscal Year 2015, of the City of Bacoor in the amount of **Twelve Million Eight Hundred Sixty Thousand Seven Hundred Fifty Pesos (Php12,860,750.00)** and allocate the same to other priority projects of the city government as approved by the Members of the City Development Council as enumerated in CDC Resolution No. 05, Series of 2018 passed on 10 July 2018;

**WHEREAS**, the priority development projects of 2015 were approved by the City Development Council through CDC Resolution 1, Series of 2015 were not implemented due to various problems, to wit:
