A RESOLUTION ENDORSING THE CONSTRUCTION OF MUSEO DE BACOR AND ACADEMY OF CULTURE AND THE ARTS TO THE TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA) TO REPLACE THE EXISTING REGIONAL TRIAL COURT (RTC), ALONG GEN. EVANGELISTA ROAD, TABING DAGAT, BACOR CITY, CAVITE.

WHEREAS, on 9 August 2018, the Office of the City Mayor sent a letter to the Sangguniang Panlungsod requesting to pass a resolution endorsing the construction of Museo De Bacoor and Academy of Culture and the Arts to the Tourism Infrastructure and Enterprise Zone Authority (TIEZA) to replace the existing Regional Trial Court (RTC) along Gen. Evangelista Road, Tabinag Dagat, Bacoor City, Cavite;

WHEREAS, the said request was referred to the Committee on Tourism, Culture and External Linkages headed by Councilor Rowena Bautista-Mendiola for further study and evaluation;

WHEREAS, the following reasons were considered by the said committee regarding the proposal to construct the Museo De bacoor and Academy of Culture and the Arts to be funded by the Tourism Infrastructure and Enterprise Zone Authority (TIEZA):

1) the Museo de Bacoor and Academy for Culture and the Arts shall be a 4-storey high building to be constructed in the old RTC along Gen. Evangelista Road. This was also the site of the first Municipal Building during the Spanish Regime and faces the Saint Michael Parish

2) the foregoing claim certainly shows that the proposed location is most appropriate as it is the historic center of the City of Bacoor and should be the focal point of the city government's tourism and cultural promotions program;

3) the architectural perspectives of the building is submitted by the City Engineering Office which include the following facilities: (a) an amphitheater on the 4th floor for cultural and art events, as well as film-showing, seminar workshops related to the promotion of the rich cultural heritage of Bacoor (b) to house a permanent exhibit on MUSIKO which depicts the rich history and colorful heritage of band parade in the city (c) museum shall also have a multi-media exhibition on the significant events in the history of Bacoor from pre-colonial period to the modern age of technology; and (d) local cultural and tourism frontline offices shall be established on the ground floor to serve as tourist information desk and cater to the welfare of the residents in the heritage district of Bacoor; and

4) the building and its facilities shall serve the following purposes: (a) repository of the city's history and culture, (b) educational, (c) local and tourism engagement, and (d) city heritage preservation.

WHEREAS, in view of the foregoing, a Committee Report was submitted to the council recommending that the request of the City Mayor's Office be approved.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in special session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to endorse the construction of Museo De Bacoor and Academy of Culture and the Arts to the Tourism Infrastructure and Enterprise Zone Authority (TIEZA) to replace the existing Regional Trial Court (RTC), along General Evangelista Road, Tabing Dagat, Bacoor City, Cavite.

RESOLVED FURTHER, to furnish the TIEZA, the Office of the City Mayor, and all government offices concerned with copies of this resolution.





