A RESOLUTION RESPECTFULLY RECOMMENDING TO THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO ALLOCATE FUNDS FOR THE PRINTING OF DIGITIZED BARANGAY BOUNDARY MAP AND TO FINANCE THE MOBILIZATION AND OTHER EXPENSES, OF THE BARANGAY BOUNDARY DISPUTES RESOLUTION TASK FORCE (BBDRTF).

WHEREAS, the City of Bacoor is comprised of 73 barangays, a number of which appear to have overlapping territorial boundaries that lead to boundary disputes between a number of barangays.

WHEREAS, in response to the growing problem, the Sangguniang Panlungsod passed City Resolution No. CR 2017-033, Series of 2017, entitled "**A RESOLUTION CREATING THE BARANGAY BOUNDARY DISPUTES RESOLUTION TASK FORCE (BBDRTF) OF THE CITY OF BACOR**" on February 20, 2017.

WHEREAS, the BBDRTF sent a letter to the Sanggunian requesting that it pass an ordinance appropriating funds to finance the printing of digitized barangay boundary maps as well as to pay for the mobilization and other related expenses of the said task force in relation to the completion of its duties.

WHEREAS, pursuant to the budget preparation process delineated under Republic Act No. 7160 and in deference to the power of the City Mayor to prepare the budget of all offices under her, the Sanggunian decided to respectfully request the City Mayor to consider the request of the BBDRTF and appropriate funds for the printing of digitized barangay boundary maps as well as to pay for the mobilization and other related expenses of the said task force in relation to the completion of its duties.
