WHEREAS, the Bacoor District Hospital ("Hospital") was established by the Provincial Government of Cavite pursuant to Sangguniang Panlalawigan Resolution No. 084, Series of 2011, and it was erected on a property donated by Senator Ramon Revilla Sr., within the jurisdiction of the City of Bacoor;

WHEREAS, the Hospital was envisioned to provide primary health care services to indigent residents of the City of Bacoor,

WHEREAS, the Hospital presently operates with a ten (10) bed capacity and is no longer adequate for the growing population of the City of Bacoor;

WHEREAS, there is a need to expand the operation of the Hospital from a ten (10)- bed capacity to a thirty (30)-bed capacity to maximize its potential and license as a Level I Hospital;

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Agreement to the Sangguniang Panlungsod for review and approval;

NOW, THEREFORE, after careful deliberation, on motion of Hon. Alde Joselito F. Pagulayan unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon.
