A RESOLUTION APPROVING THE IMMEDIATE RELOCATION OF RESIDENTS LIVING ALONG ZAPOTE RIVER, BARANGAY SAN NICOLAS 3 AS RECOMMENDED BY THE BACOOR CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL.

WHEREAS, on 17 July 2018, the City of Bacoor Disaster Risk Reduction and Management Council passed a City Resolution No. 07, Series of 2018 entitled: "A RESOLUTION RECOMMENDING THE IMMEDIATE RELOCATION OF RESIDENTS LIVING ALONG ZAPOTE RIVER, SAN NICOLAS 3 AND REQUESTING THE SANGGUNIANG PANLUNGSOD TO DECLARE THE AREA AS A NO BUILD ZONE".

WHEREAS, on 10 August 2018, the Office of the City of Bacoor Disaster Risk Reduction and Management Council sent a letter together with the aforementioned resolution to the Sangguniang Panlungsod for its review and consideration;

WHEREAS, the above subject matter was referred to the Committee on Housing and Land Utilization and to the Committee on Rules and Privileges, Laws and Ordinances for further study;

WHEREAS, the Committee Report was submitted to the Sangguniang Panlungsod recommending the approval of a resolution authorizing the immediate relocation of the residents living along Zapote River situated in Barangay San Nicolas III, Bacoor City, Cavite whose homes are in danger of collapsing due to soil erosion during the rainy season.

NOW THEREFORE, upon motion of Hon. Edwin G. Gawaran, seconded by Hon. Reynaldo D. Palabrica in regular session duly assembled, **BE IT RESOLVED AS IT IS**





