A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ENVIRONMENT MANAGEMENT BUREAU OF THE DEPARTMENT OF ENVIRONMENT REGION IV-A REGARDING THE GRANT OF FINANCIAL ASSISTANCE AMOUNTING TO EIGHT MILLION FOUR HUNDRED THOUSAND PESOS (PHP 8,400,000.00) TO THE CITY GOVERNMENT FOR THE IDENTIFICATION, DESIGNATION, DELINEATION AND CLEAN UP OF AREAS ALONG ESTEROS, RIVERS, CREEKS AND RIVER TRIBUTARIES OF ZAPOTE AND IMUS RIVER WITHIN THE CITY OF BACOR.

WHEREAS, local government units assume the primary responsibility in providing basic services and facilities to improve the quality of life of their constituents through programs and projects geared towards sustainable environmental management, climate change mitigation and adaptation and environmental degradation.

WHEREAS, in the Writ of Mandamus issued by the Supreme Court in *Concerned Residents of Manila Bay vs. MMDA et.al.* (G.R. Nos. 171947-48 dated December 18, 2008), the defendant government agencies are directed to clean up, rehabilitate, and preserve Manila Bay, so that it will be suitable for various recreational uses such as bathing, swimming and diving.

WHEREAS, to comply with the said order and provide the basic services for improved quality of life for its constituents, there is a need to authorize the City Mayor to sign and enter into a Memorandum of Agreement with the Department of Environment and Natural Resources – Environment Management Bureau (DENR-EMB) to grant financial assistance to the city government for the clean-up
