A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES REGION IV-A (BFAR ROIVA) REGARDING THE GRANT OF FINANCIAL ASSISTANCE AMOUNTING TO THREE HUNDRED THOUSAND PESOS (PHP 300,000.00) TO THE CITY GOVERNMENT FOR THE PROCUREMENT OF 50,000 PROPAGULES OF MANGROVES TO BE PLANTED IN THE WATERS OF DULONG PULO, SINEGUELASAN, BACOR CITY, CAVITE.

**WHEREAS**, on July 28, 2014, the Sangguniang Panlungsod passed City Resolution No. CR 2014-38 adopting Resolution No. 01-2014 of the City Fisheries and Aquatic Resources Management Council (CFARMC) that established the 40-hectare Protected Zone dedicated for the Mangrove Reforestation Project, considering that 957.2472 hectares of the municipal water of the City of Bacoor has already been planted with 132,000 mangrove trees.

**WHEREAS**, the Bureau of Fisheries and Aquatic Resources is again extending assistance to the local government for the planting of an additional 50,000 propagules of mangoves worth Php 300,000.00 in the said 40-hectare area situated at Dulong Pulo, Barangay Sineguelasan, City of Bacoor.

**NOW THEREFORE**, during regular session duly assembled, upon motion of Hon. Gaudencio Nolasco unanimously seconded by the Sangguniang Panlungsod, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement with the
