A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN THE GENERAL MEMORANDUM OF AGREEMENT AND THE SPECIFIC IMPLEMENTATION AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT REGARDING THE SUPPLEMENTAL FEEDING PROGRAM OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE WITH THE REGIONAL FIELD OFFICE IV-A OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT.

Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, among the priority objectives of the city government is to improve the nutrition of young Bacooreños in order to ensure that they will realize their full potential, improve their health, and help them become productive members of society.


