A RESOLUTION ADOPTING THE PARTIAL SUBSIDY SCHEME OF THE NATIONAL HEALTH INSURANCE PROGRAM AND AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR THE SAID PURPOSE.

WHEREAS, the Office of the City Mayor sent a letter to the Sangguniang Panlungsod requesting for the approval of a resolution adopting the Partial Subsidy Scheme of the National Health Insurance Program (NHIP) and authorizing the City Mayor to sign and enter into a Memorandum of Agreement in relation to the said purpose.

WHEREAS, it is the intention of the city government to enroll its constituents comprised of **Three Thousand Ninety Six (3,096) families** through the Partial Subsidy Scheme of the Sponsored Program Component of the NHIP. Under this scheme, the city government will pay the prescribed premium contribution of PhP2,400.00 for the 2019 year membership coverage of the proposed beneficiaries in the manner as described below:

Initial Payment : Three Million Seven Hundred Fifteen Thousand Six Hundred Pesos (PhP3,715,600.00).
Proposed Payment Arrangement of the Outstanding Balance:
Payable on July 2019

WHEREAS, on 8 October 2018, the Sangguniang Panlungsod passed City Resolution No. CR 2018-103 entitled: "A Resolution Adopting the National Health Insurance Program (NHIP), in Accordance with Republic Act No. 7875, As Further Amended By Republic Act No. 10606 Otherwise Known As The National Health Insurance Act of 2013".

Rowena Bautista-Mendiola in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to adopt the Partial Subsidy Scheme of the National Health Insurance Program (NHIP).

RESOLVED FURTHER, to authorize the City Mayor to sign any and all agreements or documents related to the said purpose.

RESOLVED LASTLY, to furnish the government agencies concerned with copies of this Resolution.
