**WHEREAS**, the Office of the City Mayor submitted a draft Deed of Usufruct between the City of Bacoor and the Department of Education (DepEd)-Bacoor City Division for the review and consideration of the Sangguniang Panlungsod.


**WHEREAS**, the Sangguniang Panlungsod reviewed the terms and conditions of the said Deed of Usufruct and found them to be in accord with law and beneficial to the people of the City of Bacoor.

**NOW THEREFORE**, upon motion Hon. of Venus D. De Castro seconded by Hon. Miguel N. Bautista in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign the Deed of Usufruct with the Department of Education (DepEd)-Bacoor City Division for and on behalf of the City of Bacoor in relation to the establishment, construction, and operation of various public schools in the City of Bacoor. **PROVIDED THAT** the ten (10)-year period provided under the said Deed of Usufruct shall be automatically renewed every ten (10) years unless the city government, through its duly elected Mayor, indicates in writing that it no longer wish to renew the said contract.






