










**A RESOLUTION EXPRESSING NO OBJECTION FROM THE SANGGUNIANG PANLUNGSOD ON THE PROPOSED EARTH BALLING OF MANGROVES CURRENTLY GROWING AT BACOR BAY TO GIVE WAY TO THE CONSTRUCTION OF THE LRT LINE 1 SOUTH CAVITE EXTENSION PROJECT.**

**WHEREAS**, the Sanggunian received a letter from Ms. Eleanor C. Palaypayon, OIC-Project Manager for the proposed LRT Line 1 South Cavite Extension Project requesting the city council to pass a resolution of no objection to the earth balling of various mangrove trees now growing along the banks of Bacoor Bay within the jurisdiction of the City of Bacoor.

**WHEREAS**, a public hearing was conducted by the Committee on 7 March 2019 chaired by Hon. Victorio Guerrero regarding the said request. During the hearing, Mr. Rolando Vocalan, the City Environment and Natural Resources Officer of the City, testified that the process of earth balling will ensure that the mangroves will survive even after they are removed from where they are currently situated and enable the subsequent transplantation of the said trees.

**WHEREAS**, during the same hearing, Ms. Palaypayon testified that the safe transplantation of the said mangrove trees will not only ensure the maintenance of the ecological balance in Bacoor Bay but also hasten the completion of the LRT 1 South Cavite Extension Project that in turn will help boost the local economy and improve the traffic situation in Cavite after the project is completed.

**WHEREAS**, the Committee on Environment and Natural Resources found merit in the said request and recommended the approval of a resolution expressing no objection to the earth balling of various mangrove trees now growing along the banks of Bacoor Bay within the jurisdiction of the City of Bacoor to give way to the construction of the proposed LRT Line 1 South Cavite Extension Project.
