A RESOLUTION DIRECTING THE BACOOR TRAFFIC MANAGEMENT DEPARTMENT TO STRICTLY IMPOSE THE BAN AGAINST JAYWALKING IN THE REVISED TRAFFIC CODE OF THE CITY OF BACOOR, CAVITE IN VARIOUS PLACES WITHIN THE CITY.

WHEREAS, Section 59 of City Ordinance No. 2013-047 (also known as the Revised Traffic Code of the City of Bacoor) expressly prohibits jaywalking in the following areas:

- (b) General Tirona Road
- (c) General Emilio Aguinaldo Highway
- (d) Aniban-Molino Road
- (e) Real-Salinas Road
- (f) Marcos Alvarez Road (Bacoor Side)
- (g) Zapote-Molino- Salawag Road
- (h) Molino Boulevard
- (i) Daang Hari

WHEREAS, it has come to the attention of the city council that many pedestrians ignore the said provision of law resulting in traffic gridlock and even fatal accidents.

WHEREAS, in exercise of the oversight powers of the Sangguniang Panlungsod and in order to promote public order and safety, the City Council unanimously decided to direct the Bacoor Traffic Management Department TO STRICTLY ENFORCE Section 59 of the Revised Traffic Code of the City of Bacoor in the following places:


- a) General Evangelista Road
- (b) General Tirona Road
- (c) General Emilio Aguinaldo Highway
- (d) Aniban-Molino Road
- (e) Real-Salinas Road
- (f) Marcos Alvarez Road (Bacoor Side)





