A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN THE RENEWAL OF THE MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE NATIONAL BUREAU OF INVESTIGATION (NBI) ON THE ESTABLISHMENT OF THE NBI SATELLITE OFFICE IN THE BACOR GOVERNMENT CENTER (BGC), BACOR BOULEVARD, BARANGAY BAYANAN, CITY OF BACOR, CAVITE.

WHEREAS, the NBI is presently occupying an office space within the Bacoor Government Center (BGC) located at Bacoor Boulevard, Barangay Bayanan, City of Bacoor, Cavite that serves as its Satellite Office. However, the agreement between the NBI and the city government regarding the use of the said office space is soon to expire. Thus, there is a need to renew the previous Memorandum of Agreement;

WHEREAS, the Office of the City Mayor submitted a draft of a Memorandum of Agreement renewing the said agreement alluded to above to the Sangguniang Panlungsod for review and consideration.

NOW THEREFORE, upon motion of Councilor Venus De Castro duly seconded by Councilor Alejandro F.
