A RESOLUTION DISMISSING THE COMPLAINT OF MS. MYLA I. CONSUL AGAINST MS. ANGIE CARIASO, SANGGUNIANG KABATAAN (SK) CHAIRPERSON OF BARANGAY MOLINO IV, BACOR CITY, CAVITE FOR LACK OF EVIDENCE.

WHEREAS, a complaint was filed by Ms. Myla I. Consul (the "complainant") against Ms. Angie Cariaso, Sangguniang Kabataan (SK) Chairperson of Barangay Molino IV, Bacoor City, Cavite (the "respondent") for allegedly having an illicit affair with Barangay Tanod Group Leader Mr. Alvin Consul, the complainant's husband.

WHEREAS, the said matter was referred to the Committee on Ethics and Good Governance for appropriate action.

WHEREAS, during the hearing held on 07 June 2019 conducted by the afore-mentioned Committee, only the witnesses of the opposing parties were in attendance. The complainant and the respondent did not attend the said hearing despite being duly notified by the Committee. SK Kagawad, Michael Joshua Mañago retracted his previous testimony and stated that he has no personal knowledge of the alleged illicit relationship. The complainant, on the other hand, failed to prove the alleged immoral relationship between her husband and the respondent.

WHEREAS, after a thorough review and deliberations, the Committee recommends for the dismissal of the said complaint for lack of evidence.

NOW THEREFORE, upon motion of Hon. Miguel N. Bautista seconded by Hon. Alde Joselito F. Pagulayan in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor to **DISMISS** the complaint of Ms. Myla I. Consul against Ms. Angie Cariaso, Sangguniang Kabataan (SK) Chairperson of Barangay Molino IV, Bacoor City, Cavite for allegedly having an illicit affair with the complainant's husband for lack of evidence.
