CITY RESOLUTION NO. CR 2019-053
Series of 2019

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAY TALABA VII, CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in a house in Barangay Talaba VII which rapidly spread to 150 adjacent houses in the morning of 5 July 2019 resulting in massive damage to property and the displacement of around 224 families whose houses were destroyed.

WHEREAS, the City of Bacoor Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 05, Series of 2019 dated 5 July 2019 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Talaba VII, City of Bacoor, Cavite and authorizing the release of Five Million Pesos (PhP 5,000,000.00) from the Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRRMC Resolution No. 05-S-2019 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.

WHEREAS, the Sangguniang Panlungsod convened in special session in the evening of 5 July 2019 to deliberate on the foregoing.

NOW THEREFORE, upon motion of Councilor Miguel N. Bautista duly seconded by Councilor Roberto R. Javier in special session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay
