that may be constructed thereon, situated in Camella Springville Subdivision Solid West (1, 2, 3) by the Camella Springville Molino Tricycles and Operators Association (CSMTODA) and by the homeowners associations in the said subdivisions mentioned above. **PROVIDED that:** (a) the said open space and public building shall remain the properties of the city government, (2) the CSMTODA and the various homeowners associations that will use the said properties shall not charge any rent from any member of the public for use of the said properties, (3) the said properties shall only be used as offices and not for any commercial activity/ies, (4) the Bacoor Traffic Management Department (BTMD) shall be allowed by the CSMTODA and by the homeowners' associations mentioned above to the unfettered use of the said properties, and (5) the said properties shall never be used for any purpose that is immoral, illegal, or that is contrary to public policy.

RESOLVED FURTHER, that any violation of the provisions mentioned above shall result in the automatic revocation of this Resolution.

RESOLVED LASTLY, to furnish the CSMTODA, the BTMD, and the various homeowners associations in Camella Springville Subdivision Solid West 1,2, and 3, the Office of the Mayor, and all other government agencies concerned with copies of this Resolution.

UNANIMOUSLY APPROVED this 15th day of July 2019 at the City of Bacoor, Cavite by the Sangguniang Panlungsod of the City of Bacoor, Cavite.
