A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A SISTER CITY AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND THE CITY GOVERNMENT OF PUERTO PRINCESA.

WHEREAS, the City Government of Puerto Princesa signified its interest to establish a sisterhood relationship with the City Government of Bacoor.

WHEREAS, on 03 June 2019, a copy Resolution No. 1331-2018 passed by the Sangguniang Panlungsod of Puerto Princesa City was sent by the Office of the City Legal Officer to the Sangguniang Panlungsod together with a request for the approval of a resolution authorizing Mayor Lani Mercado-Revilla to sign a "Sister City Agreement" between the aforementioned local government units.

WHEREAS, the members of the Sangguniang Panlungsod unanimously concluded that the City of Bacoor shall be greatly benefited by becoming the sister city of the City of Puerto Princesa in the fields of social, economic and tourism concerns and in other possible areas of cooperation.
