



A RESOLUTION EXPRESSING THE STRONG SUPPORT OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOR IN REQUESTING PRESIDENT RODRIGO R. DUTERTE TO ISSUE A NEW EXECUTIVE ORDER ALLOWING THE USE OF A ROUGHLY FOUR (4)-HECTARE PORTION OF A 26-HECTARE PROPERTY OWNED BY THE NATIONAL GOVERNMENT SITUATED IN BARANGAY MOLINO III FOR USE IN THE CONSTRUCTION OF A NEW HALL OF JUSTICE BUILDING AND A NATIONAL AGENCIES CENTER BUILDING AND OTHER USES BENEFICIAL TO THE PEOPLE OF THE CITY OF BACOR, CAVITE.

WHEREAS, the Office of the President issued Executive Order No. 137 s. 2002 establishing the Department of Science and Technology (DOST) Molino Housing Project involving a 26-hectare parcel of land owned by the DOST situated at Barangay Molino III in the City of Bacoor, Cavite.

WHEREAS, due to various issues, the DOST Housing Project was not implemented. In the meantime, the City of Bacoor is in need of a parcel of land on which to construct a new Hall of Justice Building in aid of the administration of justice and a National Agencies Center building for use by various national agencies in order to bring them closer to residents of the City of Bacoor and aid in the implementation of Republic Act No. 11032 ("An Act of Promoting Ease of Doing Business and Efficient Government Service").

WHEREAS, Cong. Strike B. Revilla, representing the 2nd legislative district of the Province of Cavite, sent a
