**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO ISSUE A LETTER OF NO OBJECTION (LONO) IN FAVOR OF PHILSYNC TECHNOLOGIES CO. LTD. CORPORATION IN RELATION TO ITS APPLICATION WITH THE PHILIPPINE GAMING CORPORATION (PAGCOR) AS A BPO-PROCESS OUTSOURCING PROVIDER TO OPERATE AN ONLINE OFFSHORE GAMING CORPORATION LOCATED AT BARANGAY TALABA VII, CITY OF BACoor, CAVITE.**

**WHEREAS**, the City Administrator, Mr. Jerome Oliveros, furnished the Sangguniang Panlungsod a copy of a letter dated 5 August 2019 signed by one William Choa representing Philsync Technologies Co. Ltd. Corporation ("Philsync") addressed to the City Mayor, Hon. Lani Mercado-Revilla, requesting the latter to issue a "Letter of No Objection (LONO)" in favor of Philsync in relation to its application with the Philippine Gaming Corporation (PAGCOR) as a "BPO-Process Outsourcing Provider" to operate an "online offshore gaming corporation" located at Barangay Talaba VII, City of Bacoor, Cavite.

**WHEREAS**, the said letter request was deliberated upon by the Sanggunian and a majority of its members agreed to authorize the City Mayor to issue the said LONO in favor of Philsync albeit subject to certain conditions appearing hereunder.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Alde Joselito Pagulayan **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to authorize the City Mayor to sign a Letter of No Objection in favor of Philsync for its operation of an online offshore gaming corporation within the City of Bacoor in relation to its application with the PAGCOR to be a BPO-Process Outsourcing Provider. **PROVIDED THAT:** this authority is subject to the strict, consistent, and continuous compliance of Philsync, its officers, employees, contractors, sub-contractors, agents, assigns, and successors-in-interest to the following conditions:

- a) All aspects of the online offshore gaming operation of Philsync shall comply with all the applicable provisions of the Rules and Regulations for Philippine Offshore Gaming Operations of the PAGCOR and other laws of the Republic of the Philippines;
- b) No Mayor's Permit, Business Permit, Building Permit, Environmental Clearance, Zoning Clearance, Sanitary Permit or other permits shall be issued by any official of the city government in favor of Philsync, or any of its contractors, or sub-contractors unless it/they have complied with all the existing and pertinent ordinances of the City of Bacoor;
- c) All employees of Philsync who shall work within the City of Bacoor must obtain a Work Permit and an NBI Clearance or Police Clearance before he/she is allowed to work and such employees must comply at all times with the various laws of the Philippines and with all ordinances of the City of Bacoor with regard health and sanitation, public order and safety, the promotion of public morals, the protection of the environment, and other analogous ordinances;
- d) All foreign nationals who shall be employed by Philsync and who shall work within the City of Bacoor must first obtain the necessary permits from the Department of Labor and Employment (DOLE), the Bureau of Immigration (BI), the Bureau of Internal Revenues (BIR) and other national agencies before being allowed to work thereat;
- e) The incomes derived by Philsync in its online offshore gaming operations shall be declared by it to have been earned within the City of Bacoor for local business tax purposes;
- f) The officers and managers of Philsync shall allow officials of the local government of the City of Bacoor and personnel of the Philippine National Police and other law enforcement agencies of the Republic of the Philippines to enter its business premises at all times to ensure that the foregoing terms and conditions are being consistently complied with by Philsync, its officers and managers, employees, contractors, sub-contractors, agents, assigns, and successors-in-interest;


- g) Philsync shall not be allowed to operate in more than one office building within the City of Bacoor and shall never be allowed to operate any aspect of its online offshore gaming operations within any residential area within the City of Bacoor; and
- h) The failure or refusal of Philsync to comply with any of the foregoing conditions shall result in the automatic revocation of this Resolution and of the authority granted herein in favor of the City Mayor.

**RESOLVED LASTLY**, to furnish Philsync Technologies Co. Ltd., Corporation, the Office of the City Mayor, the PAGCOR, and other government agencies concerned with copies of this Resolution.
