A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT REGARDING THE CONVERSION OF THE BACoor DISTRICT HOSPITAL INTO A LEVEL 2, 100-BED CAPACITY MEDICAL TRAUMA AND REHABILITATION CENTER TO BE KNOWN AS THE "SOUTHERN TAGALOG REGIONAL MEDICAL CENTER" THAT WILL BE PLACED UNDER THE DIRECT SUPERVISION OF THE DEPARTMENT OF HEALTH".

WHEREAS, on September 18, 2019, the Office of the Sangguniang Panlungsod received a letter from the Office of the City Legal Services requesting for a resolution authorizing the City Mayor to enter and sign a tri-partite Memorandum of Agreement among the Department of Health, the Province of Cavite, and the City Government of Bacoor.


WHEREAS, on 26 November 2018, the Sangguniang Panlungsod passed **City Resolution No. CR 2018-116** entitled " **A RESOLUTION EXPRESSING THE SUPPORT OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACoor, CAVITE IN THE CONVERSION OF THE BACoor DISTRICT HOSPITAL INTO A LEVEL 2, 100-BED CAPACITY MEDICAL TRAUMA AND REHABILITATION CENTER TO BE KNOWN AS THE SOUTHERN TAGALOG REGIONAL MEDICAL CENTER**" THAT WILL BE PLACED UNDER THE DIRECT SUPERVISION OF THE DEPARTMENT OF HEALTH."


