A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF COOPERATION FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE LOCAL GOVERNMENT OF NAIC, CAVITE REGARDING THE RELOCATION OF TWO THOUSAND SEVEN HUNDRED FORTY TWO (2,742) INFORMAL SETTLER FAMILIES LIVING ALONG THE LEGAL EASEMENTS OF RIVER, CREEKS AND THE COASTAL AREAS AND OTHER DANGER ZONES IN THE CITY OF BACOOR.

WHEREAS, the City Government of Bacoor in partnership with the National Government through the National Housing Authority (NHA) has identified resettlement sites located at Rancho Verde, Barangay Malainen, Naic, Cavite for the relocation of about Two Thousand Seven Hundred Forty Two (2,742) informal settler families living along the legal easements of river, creeks, and the coastal areas and other danger zones situated in the City of Bacoor.

WHEREAS, the Local Government of Naic, Cavite supports the city government in the relocation of its homeless constituents within the territorial jurisdiction of Naic, Cavite.

WHEREAS, the City Government of Bacoor with the assistance of various National Government Agencies (NGAs) and the Local Government of Naic, Cavite have already relocated 1,385 families to the NHA Naic Relocation Site from 2017 to 2018.

WHEREAS, the Local Government of Naic has requested the city government to provide "POST-RELOCATION ASSISTANCE" consisting of basic services, facilities, equipment and financial support which will cater to the needs of the relocated families as identified by the Local Government of Naic, Cavite.

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Cooperation (MOC) to the Sangguniang Panlungsod for its review and consideration.
