A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT AMONG THE CITY GOVERNMENT OF BACOR, THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), AND BARANGAY SAN NICOLAS II REGARDING THE COMPREHENSIVE CLEAN-UP ALONG THE ZAPOTE RIVER SYSTEM WITHIN THE CITY OF BACOR.

WHEREAS, the Department of Environment and Natural Resources (DENR) is the primary government agency responsible for the conservation, management, development and proper use of the country's natural resources;

WHEREAS, DENR Administrative Order No. 16, Series of 2019, entitled: "Expediting the Rehabilitation and Restoration of the Coastal Marine Ecosystem of the Manila Bay and Creating Manila Bay Task Force" directs the convergence of the national government agencies and the LGUs in the Manila Bay Region that includes the Province of Cavite and the active participation of private and public stakeholders, are necessary to facilitate the robust and integrated implementation of all the rehabilitation efforts at the Manila Bay;

WHEREAS, the City Government of Bacoor and Barangay San Nicolas II have committed to assist the government through the DENR in its environmental protection activities through their direct participation in the conduct of Comprehensive Clean-up along the Zapote River System located within the City of Bacoor.
