A RESOLUTION RESPECTFULLY REQUESTING THE HOUSING AND URBAN DEVELOPMENT COORDINATING COUNCIL (HUDCC) AND THE NATIONAL HOUSING AUTHORITY (NHA) TO RELEASE FUNDS NECESSARY TO FINANCE THE IN-CITY RELOCATION OF INFORMAL SETTLER FAMILIES RESIDING IN VARIOUS DANGER ZONES, ON PUBLIC EASEMENTS AND THOROUGHFARES, AND AT VARIOUS GOVERNMENT PROJECT SITES WITHIN THE CITY OF BACOR, CAVITE FOR THE PROMOTION OF THE GENERAL WELFARE.

WHEREAS, the Housing and Urban Development Coordinating Council (HUDCC) and the National Housing Authority (NHA) both play crucial roles in providing decent housing for millions of Filipinos without decent homes who are forced to reside in makeshift structures on identified geohazard sites, on public easements and thoroughfares such as riverbanks and sidewalks, and on various government project sites such as beneath bridges and flyovers.

WHEREAS, despite the best efforts of the city government to provide public housing to informal settler families residing within the territorial limits of the City of Bacoor, Cavite, its resources are not enough to finance the in-city resettlement of the afore-mentioned individuals thereby posing a threat to public safety and compromises the development of the general welfare.

NOW THEREFORE, upon the motion of Honorable Reynaldo D. Palabrica, unanimously seconded by all the members of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to respectfully request the Housing and Urban Development Coordinating Council (HUDCC) and the National Housing Authority (NHA) to release sufficient funds necessary to finance the in-city relocation of informal settler families residing in various danger zones, on public easements and thoroughfares, and at various
