A RESOLUTION DIRECTING THE CHIEF OF POLICE OF THE CITY OF BACOOR, THE BUSINESS PERMIT AND LICENSING OFFICE (BPLO), AND ALL BARANGAY OFFICIALS AND OTHER OFFICIALS OF THE CITY OF BACOOR TO STRICTLY IMPLEMENT THE PROVISIONS OF REPUBLIC ACT NO. 10932 WHICH AMENDED BATAS PAMBANSA NO. 702 OTHERWISE KNOWN AS "AN ACT PROHIBITING THE DEMAND OF DEPOSITS OR ADVANCE PAYMENTS FOR THE CONFINEMENT OR TREATMENT OF PATIENTS IN HOSPITALS AND MEDICAL CLINICS IN CERTAIN CASES".

WHEREAS, Republic Act No. 10932 was passed by Congress and was signed into law in 2017 to ensure the stricter implementation of Batas Pambansa No. 702 otherwise known as "An Act Prohibiting The Demand Of Deposits Or Advance Payments For The Confinement Or Treatment Of Patients In Hospitals And Medical Clinics In Certain Cases" and prevent the occurrence of cases where poor patients are denied access to medical care due to their failure to pay deposits at hospitals and clinics.

WHEREAS, despite the approval of the said law in 2017, many hospitals and clinics still refuse to treat patients in need of emergency treatment due to the latter's failure to pay deposits.

WHEREAS, this ignominious state of affairs must cease once and for all and the admirable intention of the legislature in passing the afore-cited laws must be implemented to the fullest extent possible.
