A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOOR AND LAS PIÑAS GENERAL HOSPITAL AND SATELLITE TRAUMA CENTER REGARDING BACOOR CITY'S SOCIALIZED HOSPITALIZATION PROGRAM.

WHEREAS, numerous indigent residents of the City of Bacoor have requested the City Government of Bacoor for the assistance in relation to their medical problems and treatment.

WHEREAS, the City Government of Bacoor desires to extend free medical services to the marginalized and underprivileged residents, public school teachers, non-teaching personnel and its local government employees in partnership with the private and government healthcare industry.

WHEREAS, the Las Piñas General Hospital and Satellite Trauma Center has suitable facilities necessary for the accomplishment of the City of Bacoor's Socialized Hospitalization Program and has manifested its willingness to render medical services to the patients referred by the City Government of Bacoor.

NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola duly seconded Councilor Alde Joselito F. Pagulayan in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement on behalf of the City Government of Bacoor with Las Piñas General Hospital and Satellite Trauma Center as part of the Socialized Hospitalization Program of the City of Bacoor.


