A CITY RESOLUTION HONORING THE MEMORY OF THE HONORABLE BENJAMIN T. ENRIQUEZ FOR HIS EXEMPLARY AND DISTINGUISHED SERVICE TO THE PEOPLE OF THE CITY OF BACOR, CAVITE.

WHEREAS, former Mayor Benjamin T. Enriquez was born on 27 August 1935. The late spouses Mr. Francisco Gervacio Enriquez Sr. and Ms. Crispina Torrijos were his parents. He was a licensed electrical engineer and obtained a degree on Electrical Engineering from the Mapua Institute of Technology. He founded his own company, Enriquez Engineering, and worked hand-in hand with his wife, Mrs. Azucena Javier Enriquez while raising their four kids.

WHEREAS, Enriquez got elected as a municipal councilor of Bacoor, Cavite from 1981-1985. He was again elected to the municipal council and served in that capacity from January 4, 1986 up to May 2, 1986.

WHEREAS, after the People Power Revolution, he was appointed Officer-in-Charge (OIC) of the Municipal Government of Bacoor by former President Corazon C. Aquino from May 3, 1986 up to December 1986.


WHEREAS, he was formally appointed by President Aquino as Mayor of the Municipality of Bacoor and served in that capacity from January to November, 1987.


