WHEREAS, Section 21 of Republic Act No.10121 and Section 1, Rule 18 of its IRR provides for the utilization of Local Disaster Risk Reduction Management (LDRRM) funds of a local government unit to support disaster risk reduction and management activities of other LGUs that are under a state of calamity or that are in imminent threat of a calamity.

WHEREAS, the City Government of Bacoor aims to help hundreds of families that were affected by the said eruption of Taal Volcano.
