A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BRIDGES OF HOPE DRUGS AND ALCOHOL REHABILITATION FOUNDATION, INC. FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR.

WHEREAS, the city government intends to establish a barangay based-rehabilitation program for the treatment and rehabilitation of drug and alcohol dependents residing in Bacoor City through the cooperation and assistance of Bridges of Hope (BH) Drugs and Alcohol Rehabilitation Foundation, Inc.;

WHEREAS, the City Legal Officer submitted a draft Memorandum of Agreement to be entered into by the city government and by the Bridges of Hope (BH) Drugs and Alcohol Rehabilitation Foundation, Inc. to the Sangguniang Panlungsod for its review and consideration;

NOW, THEREFORE, after careful deliberation, on motion of Hon. Alde Joselito F. Pagulayan duly seconded by Hon. Roberto R. Javier in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon.
