A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED BY MRS. EUFEMIA V. BRILLANTES AGAINST PUNONG BARANGAY SIEGFRIED DE LEON AND OTHER OFFICIALS OF BARANGAY QUEENSROW EAST DUE TO THE AMICABLE SETTLEMENT OF THE SAID DISPUTE.

WHEREAS, on 05 November 2019, Mrs. Eufemia V. Brillantes filed an administrative complaint against Punong Barangay Siegfried De Leon and other barangay officials of Barangay Queensrow East for the respondents' alleged failure to collect garbage in the said barangay, refusal to issue a barangay certificate in favor of the complainant, collection of excessive business clearance fees, and for allegedly exhibiting conduct unbecoming of an elected government official.

WHEREAS, the Committee on Ethics, Appointments and Government Re-organization and Committee on Barangay Affairs of the Sangguniang Panlungsod conducted a number of hearings attended by the opposing parties with regard the said allegations. At the end of the said hearings, the parties agreed to amicably settle their differences and jointly moved for the dismissal of the said complaints.

NOW THEREFORE, upon motion of Hon. Robert R. Javier, duly seconded by Hon. Reynaldo D. Palabrica and Hon. Roberto L. Advincula, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to **DISMISS** the complaint above-mentioned due to the amicable settlement of the said dispute.

RESOLVED LASTLY, to furnish the parties in the said dispute, the Department of Interior and Local Government, and other government agencies concerned with copies of this Resolution.


