CITY RESOLUTION NO. CR 2020-152

A RESOLUTION INTERPOSING NO OBJECTION TO THE OPERATION OF ELECTRONIC GAMING BY LINDUS GAMING AND LEISURE INC. LOCATED AT MOLINO TOWN CENTER, MOLINO IV, BACOOR CITY, CAVITE.

WHEREAS, Section 447, (3) of Republic Act. No. 7160 (otherwise known as the "Local Government Code of 1991") grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and to regulate any business, occupation, or practice of profession or calling which does not require government examination within the municipality and the conditions under which the license for said business or practice of profession may be issued or revoked.

WHEREAS, Lindus Gaming and Leisure Inc. (Lindus Gaming) is a domestic corporation duly organized and existing under and by virtue of Philippine laws.

WHEREAS, Lindus Gaming intends to operate electronic bingo and other games approved by the Philippine Amusement Gaming Corporation (PAGCOR) located at Molino Town Center Barangay Molino IV, City of Bacoor, Cavite.

WHEREAS, after a thorough deliberation on the said matter, majority of the members of the Sangguniang Panlungsod of Bacoor City, Cavite decided not to pose any objection to the granting of a business permit by the City Mayor to Lindus Gaming and allow the latter to operate electronic bingo and other games approved by the PAGCOR at Molino Town Center, Molino IV, City of Bacoor, Cavite subject, however, to the strict compliance of Lindus Gaming to certain conditions hereinafter set forth.

NOW, THEREFORE, upon motion of Councilor Michael Solis seconded by Councilor Reynaldo D. Palabrica in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod not to pose any objection to the granting of a business permit by the City Mayor to Lindus Gaming for the latter's operation of electronic bingo and other games approved by the PAGCOR at Molino Town Center, Molino IV, City of Bacoor, Cavite provided that the said Corporation will strictly comply with the following conditions, to wit:

- a) the said business permit shall be effective for only one (1) year, which period shall be reckoned from the date of issuance of such business permit;
- b) Lindus Gaming shall not allow any minor, or any student in uniform irrespective of age, from entering, loitering, or playing bingo or other games of chance within the premises that it intends to operate within the City of Bacoor, Cavite;
- c) the said business permit shall be limited within the City Bacoor, Cavite;
- d) Lindus Gaming must first obtain a Fire Inspection Safety Clearance from the Office of the Fire Marshall of Bacoor, Cavite before the said business permit can be issued;
- e) Lindus Gaming must submit its Certificate of Incorporation, Articles of Incorporation and By-laws as duly issued and/or approved by the securities and Exchange Commission (SEC) with the Business Permit and Licensing Office (BPLO) of the city government before a business permit can be issued to the Corporation;
- f) Lindus Gaming must submit to the BPLO and to the Office of the Secretary of the Sangguniang Panlungsod a certified true copy of its PAGCOR franchise;
- g) Lindus Gaming must pay any and all pending liabilities and taxes, which may include penalties or fines imposed against the said Corporation by past municipal administrations, that it still owe the city government before such business permit may be issued; and
- h) Lindus Gaming shall be required to pay the city government a city business tax equivalent to one percent (1%) of its gross revenues to the City Treasurer.

RESOLVED, LASTLY, that the Sangguniang Panlungsod reserves the right to repeal this Resolution and seek the revocation of any business permit granted to Lindus Gaming should the latter be found to have violated any of the foregoing conditions or any prevailing laws, ordinances, and government regulations.


