**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO MEMORANDA OF AGREEMENT WITH FOURTEEN (14) FUNERAL SERVICES PARLORS OPERATING IN THE CITY OF BACOOR REGARDING THE MEMORIAL SERVICE ASSISTANCE FOR THE BENEFIT OF CITY EMPLOYEES, BARANGAY OFFICIALS, AND INDIGENT RESIDENTS OF THE CITY OF BACOOR FOR AND ON BEHALF OF THE CITY GOVERNMENT.**
