A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED BY THE BARANGAY OFFICIALS OF BARANGAY SALINAS 1 AGAINST KAGAWAD LYNDON SANTOS DUE TO THE AMICABLE SETTLEMENT OF THE SAID DISPUTE.

WHEREAS, on 15 October 2019, majority of the elected officials of Barangay Salinas 1 filed an administrative complaint against Kagawad Lyndon Santos for alleged gross misconduct, abuse of authority, and for exhibition of conduct prejudicial to the best interest of the service.
