A RESOLUTION ADOPTING THE IMUS - YLANG YLANG - RIO GRANDE RIVERS WATER QUALITY MANAGEMENT AREA ACTION PLAN UNDER REPUBLIC ACT NO. 9275 OTHERWISE KNOWN AS THE "PHILIPPINE CLEAN WATER ACT OF 2004".

WHEREAS, pursuant to Section 5 of Republic Act No. 9275 (also known as "Philippine Clean Water Act of 2004"), the Department of Environment and Natural Resources (DENR) issued Department Administrative Order (DAO) No. 2013-02 " entitled: "Designation of Imus - YlangYlang -Rio Grande Rivers Water Quality Management Area and Creation of its Governing Board";

WHEREAS, under Section 4 , (e) iv of DAO 2013-02, the Mayor of the City Bacoor or her duly authorized representative is a member of the Imus- Ylang Ylang-Rio Grande Rivers Water Quality Management Area (IYRR-WQMA) Governing Board;

WHEREAS, Section 20 of Republic Act No. 9275 states that each Local Government Unit shall, within six (6) months after the establishment of water quality management area action plan, prepare a compliance scheme in accordance thereof, subject to review and approval of the governing board;

WHEREAS, the IYRR-WQMA Action Plan was approved by its Governing Board;

NOW THEREFORE, upon motion of Hon. Victorio L. Guerrero, Jr. duly seconded by Hon. Michael E. Solis in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to pass a resolution adopting the Imus- Ylang Ylang- Rio Grande Rivers Water Quality Management Area Action Plan.
