**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO MEMORANDA OF AGREEMENT WITH VARIOUS SCHOOLS IN THE CITY OF BACOR ON THE MATTER OF FUTURE EMPLOYMENT OF THE SENIOR HIGH SCHOOL GRADUATES OF THE CITY BACOR.**

**WHEREAS**, the Office of the City Mayor submitted to the Sangguniang Panlungsod a draft Memorandum of Agreement (MOA) between the City Government of Bacoor and the following schools:

- 1) City of Bacoor-Senior High School- San Nicolas;
- 2) St. Michael's Institute – Senior High School; and
- 3) St. Francis of Assisi College – Senior High School

**WHEREAS**, the said MOA aims to create a joint working group that seeks to promote and carry out full employment and equality of employment for all K-to- 12 graduates of the City of Bacoor to strengthen and expand the relationship between the schools, whether public or private, and the city government.






