A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN THE MEMORANDUM OF AGREEMENT AMONG THE U.P. DEBATE SOCIETY ALUMNI ASSOCIATION INC., THE DEPARTMENT OF EDUCATION-DIVISION OF BACOR CITY, AND THE CITY GOVERNMENT FOR THE TRAINING OF PUBLIC SCHOOL TEACHERS IN FORMING AND MANAGING DEBATE CLUBS IN THEIR RESPECTIVE SCHOOLS PURSUANT TO SECTION 33 OF CITY ORDINANCE NO. CO2-2016 (ALSO KNOWN AS THE "CHILD SAFETY AND PROTECTION CODE OF THE CITY OF BACOR").

WHEREAS, on 14 February 2020, officers of the U.P. Debate Society Alumni Association Inc. submitted a project proposal to the Office of the City Mayor for the training of ten (1) public high school teachers in the City of Bacoor in the formation and management of debate clubs in various public high schools within the city pursuant to Section 33 of City Ordinance No. CO2-2016 (otherwise known as the "Child Safety and Protection Code of the City of Bacoor"). Attached to the said proposal was a draft Memorandum of Agreement among the U.P. Debate Society Alumni Association Inc., the Department of Education- Bacoor City Division of Schools, and the city government.


WHEREAS, the City Mayor sent an urgent request to the Sangguniang Panlungsod to expedite the issuance of a Resolution authorizing her to sign the said agreement.






