A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A DEED OF USUFRUCT WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) – INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.

WHEREAS, on 23 of June 2008, the then Sangguniang Bayan passed Sangguniang Bayan Resolution No. 94, Series of 2008 entitled: "**A Resolution Authorizing the Municipal Mayor to Negotiate with the Department of Science and Technology (DOST) and the Industrial Technology Development Institute (ITDI) for and on Behalf of Barangay Molino III with Regard the Construction of the Proposed Barangay Hall of the said Barangay**";

WHEREAS, through the said resolution the DOST-ITDI and the Municipal Government of Bacoor made and executed a ten (10)-year Deed of Usufruct for the One Thousand Five Hundred (1,500) square meter portion of the property of the former situated in Barangay Molino III. The said contract expired on 28 August 2018;

WHEREAS, on 17 July 2019, the Hon. Mayor Lani Mercado-Revilla sent a letter to the DOST-ITDI with the intention to renew the agreement through a new Deed of Usufruct over the same property with the existing structures thereon as part of the deal;


WHEREAS, the City Legal Officer submitted a draft Deed of Usufruct to be entered into by the city government and by the DOST-ITDI to the Sangguniang Panlungsod for its review and consideration;


