**A RESOLUTION AUTHORIZING THE DISBURSEMENT OF AN ADDITIONAL THREE MILLION SEVEN HUNDRED THOUSAND PESOS (PHP 3,700,000.00) FROM THE LOCAL DRRM FUND TO BE USED FOR THE CONDUCT OF OPERATIONS OF THE AFRICAN SWINE FEVER (ASF) TASK FORCE.**

**WHEREAS**, the Sangguniang Panlungsod has declared the entire City of Bacoor under a state of calamity thru SP Resolution No. CR 2019-116 dated 08 November 2019;

**WHEREAS**, on March 07, 08 and 09, 2020, there were reported pig deaths in Brgy. Habay 2;

**WHEREAS**, on March 10, 2020, the City Veterinary Office, led by Dra. Ella Mae D. Gandia, conducted disease investigation (blood collection from surviving/sick pigs) at Brgy. Habay 2 then brought the samples to RADDL in Lipa City, Batangas for testing;

**WHEREAS**, in the morning of 12 March 2020, Dra. Ella Mae D. Gandia, City Veterinarian, received a call from Dra. May Magno, Cavite Provincial Veterinarian, informing her that one (1) sample tested positive for African Swine Fever;

**WHEREAS**, the ASF Task Force deems it as necessary to hire additional program-based personnel to activate twelve (12) animal quarantine checkpoints in the city;

**WHEREAS**, there is also a need to extend financial assistance to the affected community, especially the hog raisers;
