A RESOLUTION AUTHORIZING THE DISBURSEMENT OF AN ADDITIONAL TWELVE MILLION PESOS (PHP 12,000,000.00) FROM THE LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND OF THE CITY OF BACOR, CAVITE TO BE USED FOR THE CONDUCT OF OPERATIONS OF THE COVID-19 TASK FORCE AND OTHER RELATED EXPENSES.

WHEREAS, currently, there is a resident of the city who has tested positive for CoVID-19 as announced by the Department of Health (DOH);



WHEREAS, two (2) barangays will be lockdown within the next twenty four (24) hours as part of the stringent measures to be implemented;





