**A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAY ZAPOTE V, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF ELEVEN MILLION ONE HUNDRED NINETY EIGHT THOUSAND ONE HUNDRED THIRTY FOUR PESOS AND FIFTY CENTAVOS (PHP 11,198,134.50) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.**

**WHEREAS**, a fire broke out in a house in Barangay Zapote V which rapidly spread to 350 adjacent houses in the early morning of 23 March 2020 resulting in massive damage to property and the displacement of around 1,050 families whose houses were destroyed.

**WHEREAS**, the Bacoor City Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 08, Series of 2020 dated 23 March 2020 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Zapote V City of Bacoor, Cavite and authorizing the release of **Eleven Million One Hundred Ninety Eight Thousand One Hundred Thirty Four Pesos and Fifty Centavos (Php 11,198,134.50)** from the City Disaster Risk Reduction and Management Fund.


