CITY RESOLUTION NO. CR 2020-189  
Series of 2020

A RESOLUTION EXTENDING THE PERIOD FOR SECOND QUARTER PAYMENT FOR FISCAL YEAR 2020 OF REAL PROPERTY TAXES, BUSINESS PERMIT RENEWALS, AND OTHER FEES, TAXES, AND CHARGES DUE FOR PAYMENT ON 20 APRIL 2020 TO 20 MAY 2020 PURSUANT TO SECTION 32 OF CITY ORDINANCE NO. 2013-060 OTHERWISE KNOWN AS THE "BACOR REVENUE CODE".

**WHEREAS**, Section 32 of City Ordinance No. 2013-060 (also known as the "Bacoor Revenue Code") provides that:

"Time of Payment, - Unless otherwise provided in this Code, all taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter as the case may be. The Sangguniang Panlungsod may, through a resolution, extend the time of payment without penalties for a period not exceeding six (6) months."

**WHEREAS**, President Rodrigo Duterte issued Presidential Proclamation No. 922, s. 2020, declaring the existence of a State of Public Health Emergency throughout the Philippines due to the spread of the Coronavirus Disease 2019 (COVID 2019).

**WHEREAS**, Presidential Proclamation No. 929, s.2020, was then issued by the President placing the island of Luzon under an Enhanced Community Quarantine and placing the Philippines under a State of Calamity.

**WHEREAS**, due to the foregoing presidential proclamations, the Bureau of Internal Revenue (BIR) issued Revenue Memorandum Circular No. 22-2020 on 18 March 2020 extending the filing of income tax returns and other taxes due to the national government on 15 May 2020.

**WHEREAS**, on 25 March 2020, Mayor Lani Mercado-Revilla (who was then on quarantine), requested the Sangguniang Panlungsod through an email sent to Atty. Khalid A. Atega Jr. (the Sangguniang Panlungsod
