A RESOLUTION HOLDING IN ABEYANCE ANY ACTION ON ALL MATTERS PENDING BEFORE THE VARIOUS COMMITTEES OF THE FOURTH SANGGUNIANG PANLUNGSOD OF CITY OF BACOR (2019-2022) PRIOR TO THE PLACEMENT OF THE ISLAND OF LUZON UNDER THE ENHANCED COMMUNITY QUARANTINE DUE TO THE CORONAVIRUS DISEASE 2019 (COVID 2019) PANDEMIC.

WHEREAS, President Rodrigo Duterte issued Presidential Proclamation No. 922, s. 2020, declaring the existence of a State of Public Health Emergency throughout the Philippines due to the spread of the Coronavirus Disease 2019 (COVID 2019).


WHEREAS, Presidential Proclamation No. 929, s.2020, was then issued by the President placing the island of Luzon under an Enhanced Community Quarantine and placing the Philippines under a State of Calamity.

WHEREAS, in view of the placement of the island of Luzon under the Enhanced Community Quarantine on 16 March 2020, all committee hearings of the 4th Sangguniang Panlungsod were put on hold pursuant to the various protocols on the said quarantine issued by the Inter Agency Task Force to Control Infectious Diseases (IATF).



RESOLVED FURTHER, to require the Sangguniang Panlungsod Secretariat to furnish the proponents of, or affected parties in, all matters pending action before the various standing committees of the Sangguniang Panlungsod with copies of this Resolution by means of an e-mail, text message, or instant message within three (3) working days after the issuance hereof.

RESOLVED LASTLY, to furnish the Office of the City Mayor, all city government departments and units, and all government agencies concerned including the Department of Interior and Local Government (DILG) with digital copies of this Resolution via email within three (3) working days after the issuance hereof.


ADOPTED on the 30th day of March 2020 by a unanimous vote of all the members of the 4th Sangguniang Panlungsod of the City of Bacoor, Cavite during a regular session conducted online held in the City of Bacoor, Cavite with the use of a videoconferencing application approved by a majority of its members.
